1 GENERAL PROVISIONS

ayondo takes data protection and data security very seriously. Accordingly, we hereby give an undertaking to treat your data in confidence. Third parties will only receive your personal data as far as this is permitted by data protection laws, ordered by a competent authority or if you explicitly consent to it.



2 COMPLIANCE WITH THE GENERAL DATA PROTECTION REGULATION (DIRECTIVE 2016/679/EC OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL OF 27 APRIL 2016)

ayondo GmbH, ayondo portfolio management GmbH and ayondo markets (hereinafter collectively referred to as "ayondo-companies") jointly operate the website www.ayondo.com, and each of these companies offers its services to customers via the website. The ayondo-companies are therefore jointly responsible for data processing in accordance with Article 26 of the General Data Protection Regulation and will at all times fulfil the resulting obligations. This includes the case where the ayondo-companies have internally concluded an agreement on who fulfills which obligations under the General Data Protection Regulation. On request, the ayondo-companies will provide customers with the essential terms of this agreement. Notwithstanding the details of the aforementioned agreement, however, any persons concerned may exercise their rights with and against any ayondo-company.

3 PERSONAL DATA

Personal (""person-linked"") data is data that can be unambiguously assigned to a specific individual, and can thus be used to obtain personal or factual information about you.



4 WHAT TYPES OF DATA DO WE GATHER AND STORE, AND FOR WHAT PURPOSE?

In connection with the use of the website on which we offer our services, data is stored on our servers even if a contract with the customer is not concluded. This data are regularly deleted. No personal-linked evaluation is carried out. The statistical evaluation of pseudonymized or anonymous data sets is reserved. For example, it is stored for system security reasons as IP-logs, for improving the website and for the purposes of statistics. Please note that we use Google Analytics (in respect of the use of Google Analytics please see section 7).

For other purposes the processing and use of your data only takes place if you have expressly agreed to this use. For example, your data will not be used for promotional purposes without such consent. You will only receive advertising from ayondo if you have expressly given your consent. You can revoke this consent at any time by sending an email to service@ayondo.com.

5 DOES AYONDO USE COOKIES?

ayondo uses "cookies" within the use of Google Analytics (in respect of the use of Google Analytics please see clause 7). Cookies are used solely to determine the frequency of both the use and the number of users of our website, or to optimize the display of advertising messages. On certain pages advertisements from companies or agencies are delivered directly: cookies and/or web beacons may be used without influence from us or without us being able to notify you about it. The respective advertiser is responsible for this.



Use of our service is also possible without cookies. Most browsers are pre-configured to accept cookies automatically. However, you can disable the storage of cookies or allow them only on demand. We should point out that you may be able to use our website only under restricted conditions when cookies are rejected.

6 DO WE PASS ON YOUR DATA TO THIRD PARTIES?

In certain cases, legal provisions require us to pass on your personal data to third parties, such as, for example, criminal prosecution agencies

In all other instances your data is stored exclusively in our database and on our servers, or those of companies contracted by us to process data. Otherwise, data is passed on to third parties but only if you have previously consented.

ayondo shall not be held liable for the confidential handling of your data by third parties as such matters are beyond our control. Our Website, for example, contains links to other websites. We are unable to ensure that the operators of such sites comply with the privacy policy.

7 USE OF GOOGLE ANALYTICS

This website uses Google Analytics, a web analytics service provided by Google, Inc. ("Google"). Google Analytics uses "cookies", which are text files placed on your computer to help the website analyse how visitors use the site. The information generated by the cookie of your use of the website (including your IP address) will usually be transmitted to, and stored by, Google on servers in the United States. However, in the case of the activation of the IP anonymity on this



website, your IP address will be previously abridged by Google within the Member States of the European Union or in other states bound by the Agreement on the European Economic Area. Only in exceptional cases will the full IP address be transferred to a Google server in the US and abbreviated there. On Behalf of the operator of this website Google will use this information for the purpose of evaluating your use of the website, compiling reports on website activity for website operators and providing other services relating to website activity and internet usage. Your personal data will be securely transmitted by encryption on our website. We use the encoding system SSL (Secure Socket Layer). In addition, we protect our website and other systems by technical and organizational measures against the loss, destruction, access, alteration or dissemination of your data by unauthorized persons.
